Schools/Youth Access

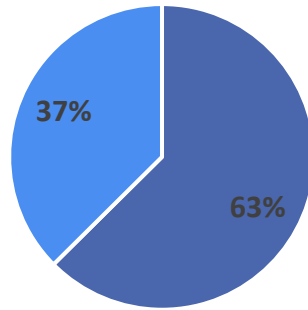
- Education staff and Central Region officers collaborated on a brief requested by a local school to help parents understand responsibilities during graduation celebrations.

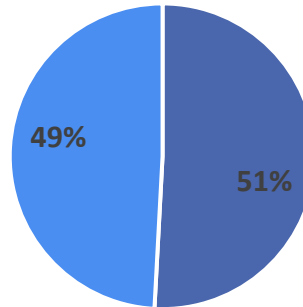

Retail Liquor



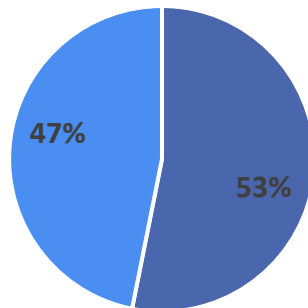

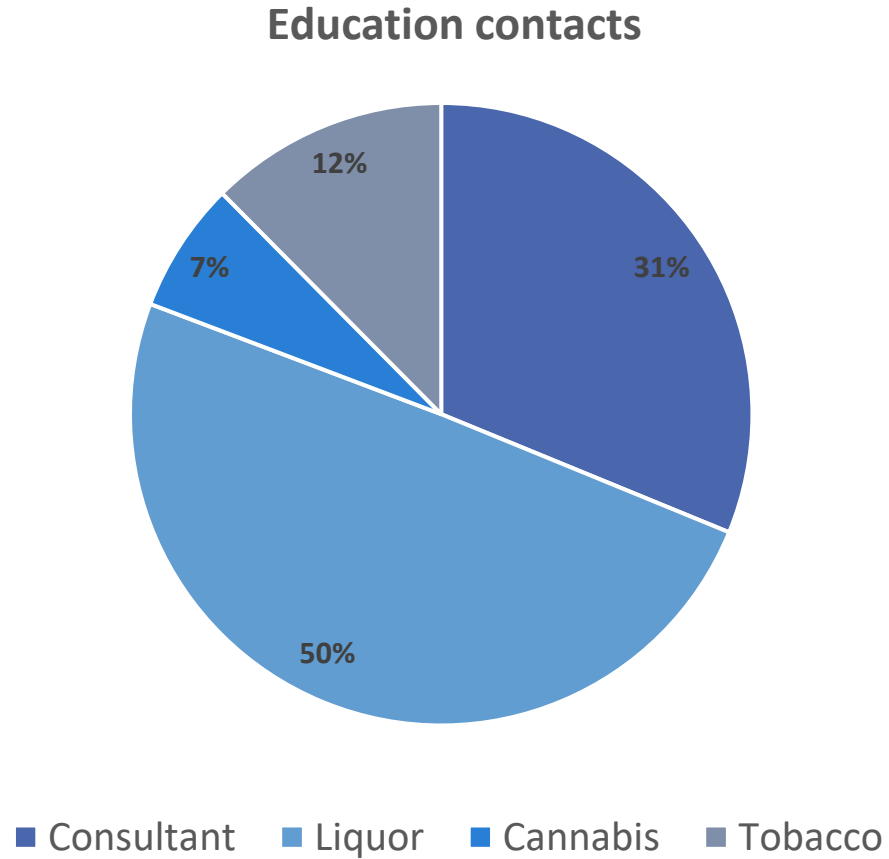
- Teams spent a greater average of ours in office

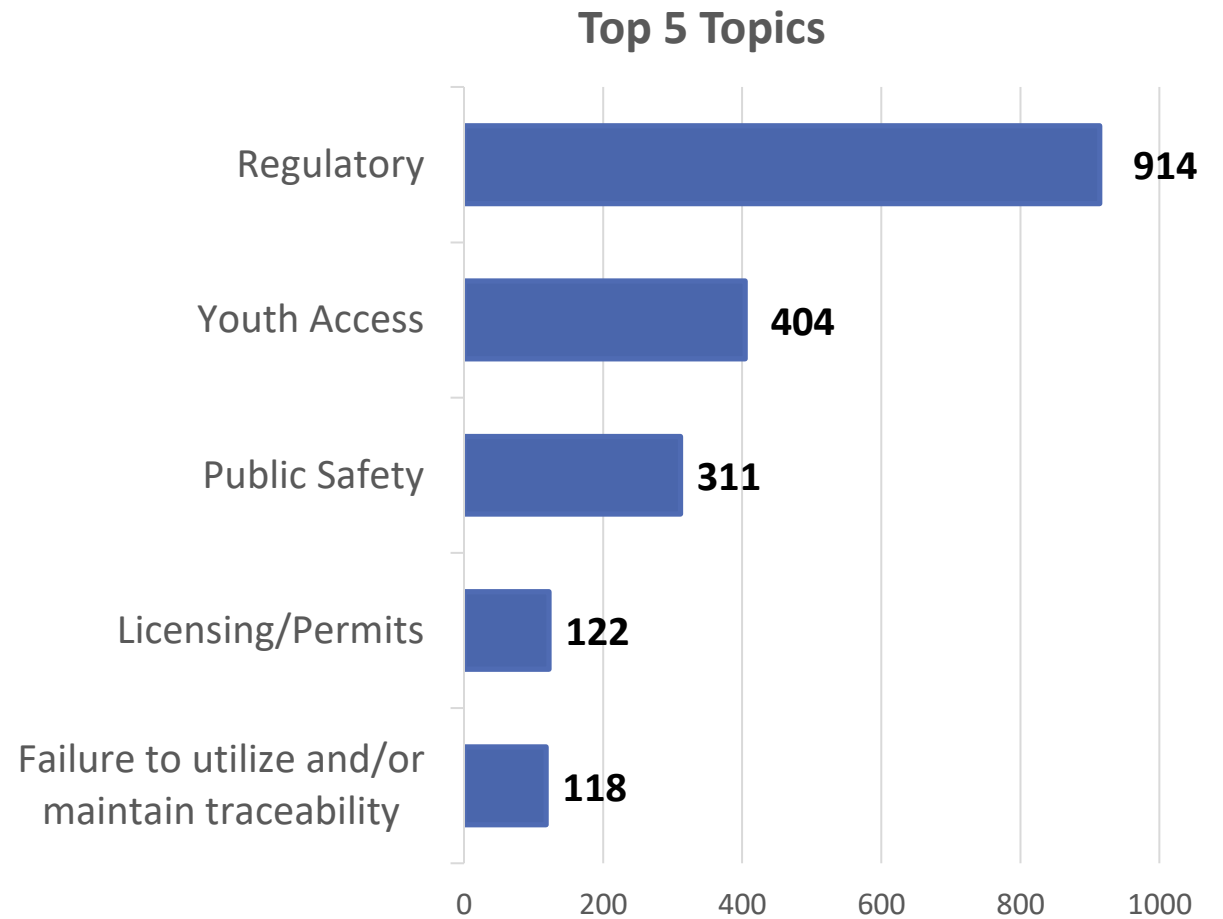

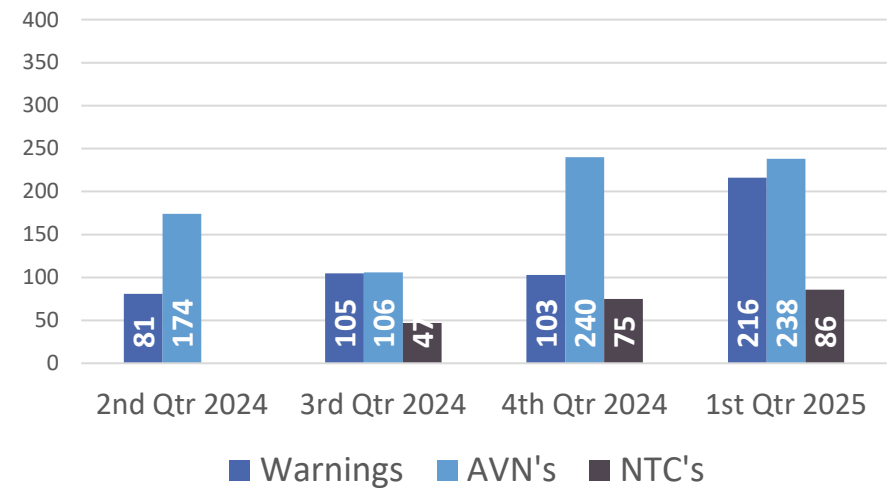

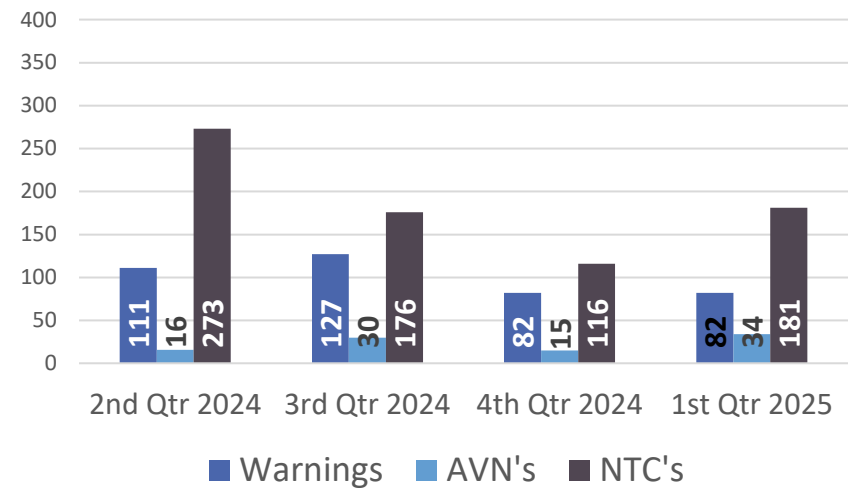

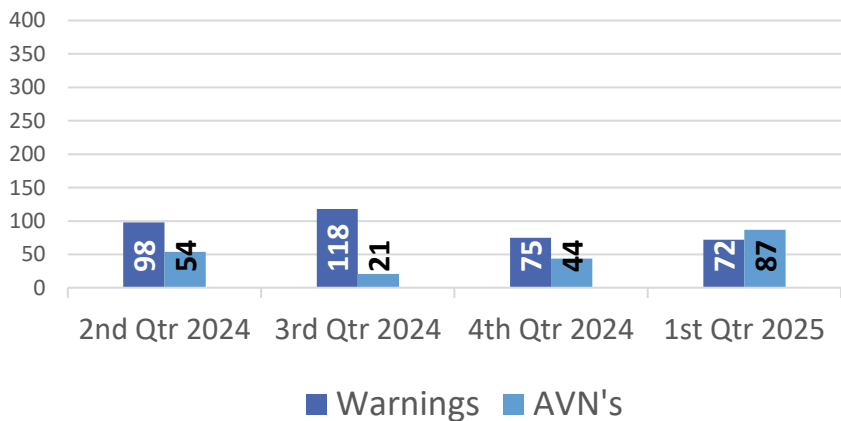

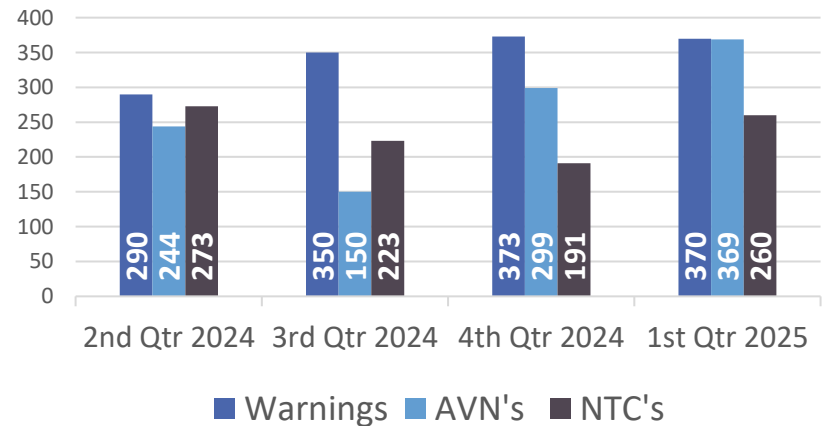
Cannabis
