### **LEGISLATIVE UPDATE – Marc**

Marc noted that the agency's legislative agenda passed, including two agency-request bills and the confirmation of Chair Vollendroff and Member Holmes. He previewed topics for consideration in the interim in anticipation of the next legislative session.

# **LICENSING UPDATE – Becky**

Becky shared that teams have met with the City of Lynnwood, Yakima, and the Association of Cities in an attempt to open more options for retail cannabis and social equity licensees. The new Licensing Education, Enforcement and Administrative Data System (LEEADS) went live on March 31 and the team continues to work through technical challenges that have arisen, including delays in processing times and a substantially increased volume of phone calls for assistance.

# **ENFORCEMENT & EDUCATION UPDATE - Larry**

Larry reported compliance numbers and other statistics for March 2025 (PRESENTATION 1).

### **COMMUNICATIONS UPDATE - BRIAN**

Brian updated on recent media requests that have been received and highlighted his team's role in the Systems Modernization Project and the Sharepoint Online project.

### **POLICY UPDATE - JUSTIN**

Justin reported on the number of rules petitions that the Policy team is working on, including some internal requests. The Research team is focusing on their dashboards, product placement and general marketing strategies.

### **GENERAL AGENCY UPDATE - TONI**

Toni provided updates on the System Modernization Project (SMP) and noted that the LEEADS portal had more technical difficulties than they had anticipated, but they are being corrected in a systematic manner. The Employee Engagement Survey exposed a desire for more collaboration between divisions, so possible action items are being considered in response to that request. Anita Bingham has announced her retirement, so recruitment is in process for a new Human Resources Director.
