ENFORCEMENT AND EDUCATION UPDATE - CHANDRA

Brian shared some Licensing notes provided by Becky Smith, including a staffing report for the liquor unit which has necessitated 99 file reassignments among 16 licensing specialists in one week. Sarah Davis, the case manager for social equity, has been reaching out to applicants, and although several applicants will be ready in the near future, Sarah has shared that some of their continued frustrations are around financing and finding a viable location.

Brian reported on media requests received by the Communications team, his participation at the Cannabis Regulators Association (CANNRA) meeting, the progress on the annual report, the website and Sharepoint Online.

POLICY UPDATE - JUSTIN

Justin reported on his attendance at CANNRA and provided many updates from his division. The Department of Health and The Cannabis Alliance held a joint town hall meeting in Seattle surrounding medical cannabis where one of the strongest needs identified for medical cannabis patients is accessibility.

DIRECTOR'S COMMENTS - WILL

Will mentioned a number of meetings that he has attended with liquor and cannabis associations and licensees, including a tour of a licensee with some of the agency's partners, such as Department of Commerce, Department of Agriculture and Department of Health.
