Board Approval of CR 101 Regarding Substitute House Bill 1453 – Medical Cannabis Tax Implementation

Jeff briefed on a CR 101 to implement Substitute House Bill 1453 to exempt qualifying patients or designated providers issued a recognition card, purchasing cannabis identified by the Washington State Department of Health in chapter 246-70, from a cannabis retailer issued a

Board Approval of CR 102 for Medical Cannabis Endorsements Denise Laflamme, Policy and Rules Coordinator

Denise previewed a CR 102 to amend WAC 314-55-080 on Medical Cannabis Endorsements, with three primary goals, to create a requirement of posting cannabis consultant availability alongside required store hours, to allow medical cannabis endorsement holders to have cannabis products that comply with WAC 246-70 "on order" to satisfy the "in stock" requirement, and to create a 30-day "cure period" to allow medical cannabis endorsement holders to correct regulatory noncompliance before an endorsement will be discontinued for noncompliance.

Board Approval of CR 102 Regarding WAC 314-11-050 – Prohibited Conduct Justin Nordhorn, Policy and External Affairs Director

Justin provided a brief overview of CR 102 to repeal WAC 314-11-050 and other references to it in Title 314 WAC, consistent with Engrossed Substitute Senate Bill 6105. No new rules are being created, only repealed or language removed in order to comply with a legislative mandate in sections 4 and 5, chapter 250, Laws of 2024.
