AGENCY STRATEGIC PLAN REVIEW Jessica Dang, Strategy and Performance Manager

Jessica presented the 2024 – 2029 Strategic Plan Update (PRESENTATION 1).

POLICY AND RULES TEAM UPDATES AND BOARD MEETING PREP General Updates – Cassidy West, Policy and Rules Manager

Cassidy provided general updates and timeline items.

Rules Petition Review and Consideration Requesting to Amend Title 314 WAC to Update Personal Pronouns and Change Remaining Occurrences of "Liquor Control Board" to "Liquor and Cannabis Board"

Jeff Kildahl, Policy and Rules Coordinator

Jeff briefed on a petition request for updates to be made to the usage of pronouns in the text of the rules throughout Title 314 WAC and for rulemaking to update the former name "Liquor Control Board" where it still remains in the same WAC. Kildahl noted that the requested changes align with the LCB's goals and priorities.

Board Approval of CR 105 for Updating LCB Name and Acronym in Title 314 WAC Rules Jeff Kildahl, Policy and Rules Coordinator

Jeff requested Board approval to file a notice of expedited rulemaking (CR 105) to change the remaining occurrences of "Liquor Control Board" to "Liquor and Cannabis Board" in Title 314 WAC. The amendments are needed to implement a requirement of Second Substitute Senate Bill 5052 to update the agency name and the acronym of the agency.

Board Approval of CR 101 for Cannabis Payment Flexibility Daniel Jacobs, Policy and Rules Coordinator

Daniel previewed a CR 101 for Cannabis Payment Flexibility for the Board to consider amending WAC 314-55-115(1) and repealing or creating other sections of Title 314 WAC to allow cannabis licensees purchasing cannabis from other licensees greater flexibility when paying via check than is currently allowed in rule.

Update on the Medical Cannabis Excise Tax Exemption Justin Nordhorn, Policy and External Affairs Director

The medical cannabis excise tax exemption bill is in effect on June 6th and retail licensees are eligible to provide the excise tax exemption to qualified medical cannabis patients even though the rulemaking for implementation hasn't been completed. The store has to be a medical cannabis endorsed store, must be selling product to a qualified medical cannabis card-holding patient, and the product must be medically qualified product under the Washington Department of Health's WAC 246-70-040.
