8/27/25 ALCOHOL ADVISORY COUNCIL UPDATE Pete Holmes, Board Member

General Updates and Timelines All Industries - Kevin Walder, Policy and Rules Manager

Kevin provided an overview of the current Rules team activities and timeline items.

Board Adoption of CR 103 for Acceptable Forms of Identification – Jeff Kildahl, Policy and Rules Coordinator

Jeff presented a CR 103 to amend rules regarding the acceptable forms of identification that liquor and cannabis licensees may use to verify a person's age for eligibility to purchase alcohol and recreational cannabis products.

Rules Petition Review and Consideration of Unfair Cannabis Business Practices- Denise Laflamme, Policy and Rules Coordinator

Denise previewed a rules petition requesting action be taken related to what is described as unfair and illegal business practices by certain chains of cannabis retailers in violation of WAC 314-55-018.

BOARD MEMBER AND EXECUTIVE ASSISTANT REPORTS

Member Garrett announced that AltaPoint Consulting completed the transfer of all of the registrations for the new round of social equity licensing yesterday. The contractor that is doing the double-blind lottery received information for the registrants with the highest scores and there are 21 registrants going into the lottery for the 15 licenses that are available. Also, Garrett is expanding the Cannabis Advisory Council membership by inviting a medical cannabis patient and two social equity retail licensees, one from each side of the state.
