This letter contains important information about your liquor license

On April 7, 2010, the Liquor and Cannabis Board adopted a resolution which formally recognizes the **Downtown Urban Core Alcohol Impact Area** requested by the City of Spokane. The Alcohol Impact Area includes:

Beginning at the southwest corner of Lot 10, Block 13 of Dennis and Bradley's Subdivision, said point also being the northeast corner of vacated Dakota Street and Trent Avenue; thence westerly along the north right-of-way of Trent Avenue to the east section line of Section 18, Township 25 North, Range 43 East, W.M. (Division Street centerline), city of Spokane, Spokane County, Washington; thence westerly along the north right-of-way line of Spokane Falls Boulevard to the north right-of-way line of Main Avenue; thence westerly along said north right-of-way line of Spokane Falls Boulevard to said north right-of-way line of Main Avenue; thence westerly along said north right-of-way line of Main Avenue to the northeast corner of Parcel No. 25134.3101, said point also being the northwest corner of Main Avenue and Elm Street; thence southwesterly to the southwest corner of Riverside Avenue and Cannon Street; thence southerly, along the west right-of-way line of Cannon Street to the southwest corner of Cannon Street and Fifth Avenue; thence easterly along the south right-of-way line of Fifth Avenue to the southeast corner of Fifth Avenue and Scott Street; thence northerly along the east right-of-way line of Scott Street and the south right-of-way line of Sprague Avenue; thence northerly to the true point of beginning.

What is an Alcohol Impact Area?

An alcohol impact area is an area of a city or town that is experiencing significant problems with chronic public inebriation or illegal activity associated with alcohol sales or consumption. Under Liquor and Cannabis Board regulations (WAC 314-12-210 through WAC 314-12-225), a city or a town may request formal recognition of an Alcohol Impact Area by the Liquor and Cannabis Board. Recognition can only occur after the city has met the requirements outlined in the Alcohol Impact Area rules.

How Does the Alcohol Impact Area Affect My Liquor License?

- Extended license notification times: The Liquor and Cannabis Board's formal recognition of
 the Alcohol Impact Area means the agency will give the City of Spokane more time to
 comment on new license applications and renewals for businesses that sell beer or wine togo within the Alcohol Impact Area. The City of Spokane now has 60 days to comment on
 applications or assumptions that include sales to-go within the Alcohol Impact Area
 (previously 20 days), and 90 days to comment on renewals within the Alcohol Impact Area
 (previously 60 days).
- 2. <u>Beer and wine product restrictions</u>: Along with formal recognition of the Spokane Alcohol Impact Area, the Liquor and Cannabis Board approved mandatory beer and wine product restrictions based on a list of products identified by the City of Spokane as linked to

problems associated with chronic public inebriation. You may not stock or sell beer and wine products on the Banned Products List for off-premises sale ("to go"). In the future, should the City of Spokane identify additional beer or wine products as reasonably linked to problems associated with chronic public inebriation, they may request that the Liquor and Cannabis Board also restrict these additional products. We will notify you if the Board approves further product restrictions.

If you are a restaurant or tavern, you may still sell these products for consumption on your licensed premises, but not to-go.
