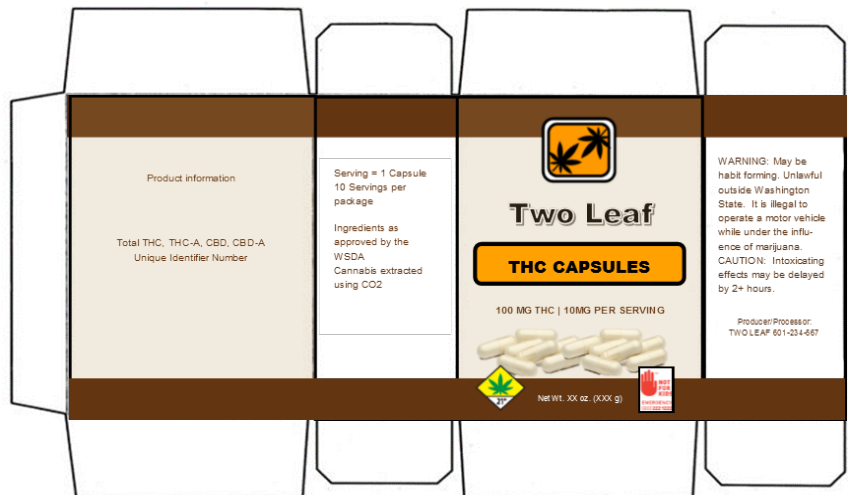
Example Packaging and Labeling for Marijuana Infused Edibles

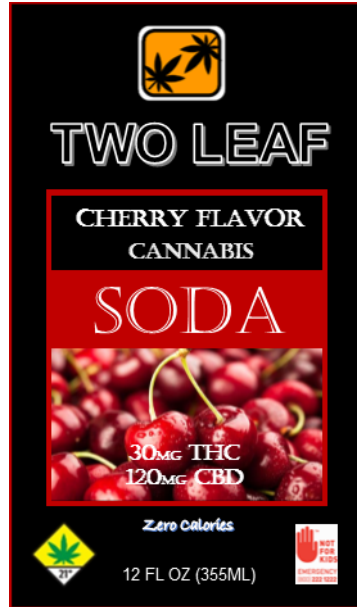
Capsule or Tablet

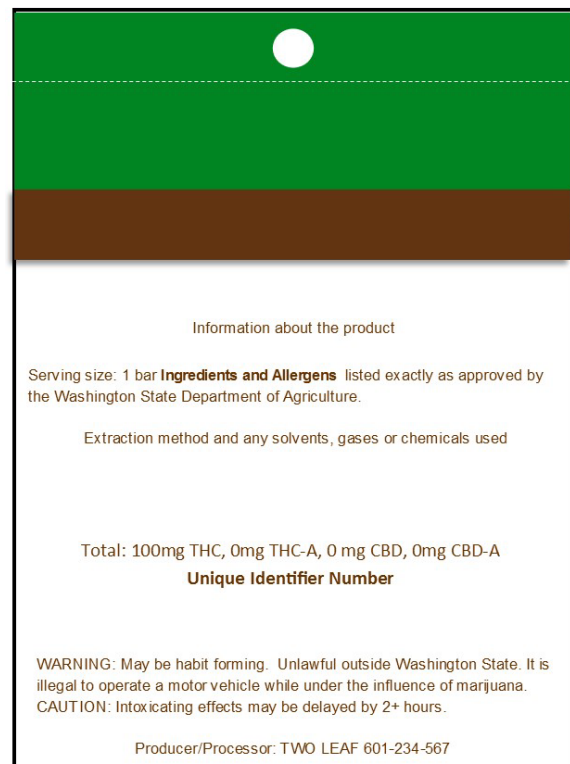

Applies to all products, packaging and labeling

1. The business or trade name and the nine digit Washington State Unified Business Identifier (UBI) number of the licensees that produced and processed the marijuana or marijuana products. Retailer name and UBI is optional.
2. The unique identifier number generated by the WSLCB's traceability system. This must be the same number that appears on the transport manifest. Using a barcode is not required.
3. If more than one serving is in a package, the label must prominently display the number of servings in the package and the amount of product per serving
4. Net weight in ounces and grams or volume as applicable.
5. THC concentration (delta-9 tetrahydrocannabinol) listed as total THC and activated THC-A and CBD concentration (cannabidiol) listed as total CBD and activated CBD-A. Adding the THC and CBD together to get the total milligram is incorrect. Totals must be listed separately.
6. Warning Statements can be listed together or separately on the package or label.
 - Warning - May be habit forming
 - Unlawful outside Washington State
 - CAUTION: Intoxicating effects may be delayed by 2+ hours.
 - It is illegal to operate a motor vehicle while under the influence of marijuana
 - The marijuana universal symbol and Not for Kids symbol as provided in WAC 314-55-106
7. Serving size and the number of servings contained within the unit.
8. A list of all ingredients in descending order of predominance by weight or volume as applicable and a list of major food allergens as defined in the Food Allergen Labeling and Consumer Protection Act of 2004. All ingredients have to be approved by the WSDA and submitted. Ingredients have to be listed as approved by the WSDA. The order and wording of the ingredients must remain the same.
9. If solvents were used, a statement that discloses the type of extraction method, including any solvents, gases, or other chemicals or compounds used to produce or that are added to the extract. Anything added in the process to extract the cannabis is considered a solvent. Examples how this requirement can be listed:
 - This product is made from CO2 extract of cannabis
 - This product is made from food grade alcohol extract
 - Marijuana was extracted using cane alcohol
 - CO2 was used in the extraction of the cannabis in this product
 - Extraction method: list the extraction method
10. Optional information on packaging and labeling: Harvest date, Best by date, and Manufacture date.
11. Pesticide statement required for accompanying materials. May be made available to the consumer purchasing marijuana products at retail. A producer or processor may provide this information through an internet link, web address, or QR code on the product label so long as the information particular to that

product as required below is maintained and accessible to a consumer for as long as the product is available for sale at retail.

12. Labels of usable marijuana and marijuana products sold at retail in the state of Washington must not contain any statement, depiction, or illustration that:
 - Is false or misleading;
 - Promotes over consumption;
 - Represents the use of marijuana has curative or therapeutic effects;
 - Depicts a child or other person under legal age consuming marijuana, or includes:
 - Objects such as toys, characters suggesting the presence of a child, or any other depiction or illustration designed in any manner to be especially appealing to children or other persons under twenty-one years of age; or
 - Is designed in any manner that is especially appealing to children or other persons under twenty-one years of age.
13. Package and label background are limited to the following approved colors: white, black, gray, cream, brown or tan. (Background color does not count as one of the three approved accent colors)
14. Packaging and Labels are limited to up to three approved accent colors available on the LCB website. A tint, percentage or gradient of an approved color counts as one of the three colors. Text color(s) can be any of the approved accent colors. Text color(s) is one of the three accent colors.

Specific to tincture packaging

- If more than one serving is in a package, the label must prominently display the number of servings in the package and the amount of product per serving. For example: 25 servings per bottle, 2 mg THC, .4mg CBD per serving.
- Serving size and the number of servings contained within the unit. For example: Serving size = 1 pipette.

Specific to capsule or tablet packaging

- If more than one serving is in a package, the label must prominently display the number of servings in the package and the amount of product per serving. For example: 10 servings per package, 10 mg THC per serving.
- Serving size and the number of servings contained within the unit. For example: Serving size = 1 capsule.

Specific to liquid packaging

- If more than one serving is in a package, the label must prominently display the number of servings in the package and the amount of product per serving. For example: 3 servings per package, 10 mg THC and 40mg CBD per serving.
- Serving size and the number of servings contained within the unit. For example: Serving size = 4fl oz.

Specific to solid packaging

- If more than one serving is in a package, the label must prominently display the number of servings in the package and the amount of product per serving. For example: 10 servings per package, 10 mg THC per serving.
- Serving size and the number of servings contained within the unit. For example: Serving size = one truffle.
