1. CALL TO ORDER

ACTION ITEM (A)

ACTION ITEM 4A - Board Adoption of CR 103 for 2020 Legislation Implementation – HB 2412, ESSB 5006, ESSB 6095 and SSB 6392

Audrey Vasek, Policy and Rules Coordinator, began the briefing with materials (HANDOUT 4A).

Ms. Vasek: Today I am requesting approval of the CR 103 package and final rules for implementation of four alcohol related 2020 bills: House Bill (HB) 2412 – related to brewery keg registration and identification requirements; Engrossed Substitute Senate Bill (ESSB) 5006 – related to on-premises consumption endorsements for breweries and wineries; Engrossed Substitute Senate Bill (ESSB) 6095 – related to interstate common carriers; and Substitute Senate Bill (SSB) 6392 – related to local wine industry associations.

For background, the Board initiated a formal rule inquiry to consider revisions to implement these bills on July 22, 2020. To engage interested members of the public in the rulemaking process, we offered conceptual draft rule language for feedback through email messaging sent to GovDelivery subscribers in September, 2020. The CR 102 and proposed rules, which were filed on November 18, 2020, took into consideration the public feedback received. A description of the changes made based on this feedback

was provided during the presentation on November 18, and in a follow up email sent to the individuals who provided feedback. A table containing this feedback and a copy of the GovDelivery messaging were included as attachments to the CR 102 memo presented to the Board. The public hearing was held on January 6, 2020 (sic)[2021]. Two people offered oral testimony and no written comments were received. The two comments were in support of the proposed rules and did not suggest any changes. These comments are captured in the concise explanatory statement.

The final rules align existing rule language with changes made to the law by HB 2412, ESSB 6095 and establish new rule sections needed to implement ESSB 5006 and SSB 6392. A more detailed description of the rulemaking background and the new and amended rules sections is included in the CR 103 memo.

If the CR 103 is approved today, I will file the rules with the Code Reviser's office and send the concise explanatory statement to all persons who provided public comment. The effective date of the rules will be February 20, 2021, which is 31 days after filing. Thank you very much for listening, are there any questions I can answer about this CR 103 package?
