Subject: Approval to file a pre-proposal statement of inquiry (CR 101) regarding cannabis samples.

The Washington State Liquor and Cannabis Board (WSLCB) is considering changes to WAC 314-55-096 to review Cannabis Sample rules.

Process

The Policy and Rules Coordinator requests approval to file the pre-proposal statement of inquiry (CR 101) for the rule making described above. A CR 101 Memorandum was presented at the Board meeting on March 1, 2023, and is attached to this order.

If approved for filing, the *tentative timeline* for the rule making process is outlined below:

March 1, 2023	Board is asked to approve filing pre-proposal statement of inquiry (CR 101). CR 101 filed with the Office of the Code Reviser. LCB webpage updated and notice circulated by GovDelivery distribution list. Informal comment period begins.
March 15, 2023	Notice is published in the Washington State Register under WSR issue #23-06.
April 14, 2023	The informal comment period ends.
May 24, 2023	Board is asked to approve filing proposed rules (CR 102). CR 102 is filed with the Office of the Code Reviser.

June 7, 2023	Notice is published in the Washington State Register under WSR issue #23-11.
July 19, 2023	Public hearing is held and the formal comment period ends.
August 16, 2023	Board is asked to adopt rules, if no substantive changes are made (CR 103). Concise explanatory statement is provided to individuals offering written or oral comment at the public hearing or during the formal comment period under RCW 34.05.325. CR 103 and adopted rules are filed with the Office of the Code Reviser. LCB webpage is updated and notice is circulated by the rules distribution list.
September 16, 2023	The rules are effective 31 days after filing unless otherwise specified. See RCW 34.05.380(2).

CR 101 Memorandum

Regarding Cannabis Samples.

Background

On July 8, 2022, Vicki Christopherson, on behalf of the Washington Cannabusiness Association, submitted a petition for adoption, amendment or repeal of a state administrative rule to the Washington State Liquor and Cannabis Board (Board). The petition requested that the Board amend WAC 314-55-096, concerning vendor, educational and internal quality control samples, in an effort to update and streamline requirements. The petition also referenced the amount of time the current rule had been in effect, and that an update was warranted.

On August 31, 2022, the Board accepted the petition. Consistent with RCW 34.05.330(1)(b), the Board agreed to initiate the rulemaking process and begin collaboratively engaging with stakeholders and any interested members of the public to explore potential rule revisions related to vendor, educational and internal quality control samples.

Reasons Why Rules May Be Needed

Amendments may be necessary to update and streamline WAC 314-55-096 concerning cannabis vendor, educational, and internal quality control samples. Additionally, amendment, repeal, or the creation of new rule sections in Title 314 WAC may be needed to align potential revisions to WAC 314-55-096,

Process

The rule making process begins by announcing the Board's intent to consider changes to existing rules, adding new rule sections, or both by filing a CR 101 form with the Office of the Code Reviser. This allows staff, stakeholders, industry partners, and all members of the authorizing environment to begin discussing proposed rule changes.

At the CR 101 stage of the rulemaking process, no proposed language is offered. Any interested party may comment on the subject of this possible rulemaking during the designated comment period. Notice will be sent to all who have indicated that they want to receive notice of rule activity pertaining to this preproposal inquiry. The notice will identify the public comment period and where comments can be sent.
