SUBJECT: University of Washington (UW) – Request for Permanent Approval of Piloted Levels of Service

Representatives for UW have requested consideration of permanent approval of the levels of service included in their pilot program previously approved for the 2023 football season. If approved, this would allow for a permanent exception to the levels of alcohol service within their operating plan. Per WAC 314-02-058(3)(b); "if alcohol service is requested outside of the parameters of the approved chart, a special request with justification for the alcohol service area must be submitted with the operating plan for consideration by the board."

The University of Washington is respectfully requesting the following:

Beer and Wine in General Seating

The permanent allowance of beer and wine in the stands for general seating which would continue to be prohibited in the student section. Concession stands will continue to sell no more than two drinks per transaction and will ensure proper identification checks occur to ensure there are no sales to minors. All beer and wine will be in clear plastic glasses, which will differ from any non-alcoholic drinks. To assist with overconsumption prevention, the arena will continue to deny exit and re-entry of guests outside the arena. There are no beer gardens proposed for home Husky football games for 2024.

Pilot Program Review

Representatives from Licensing, Enforcement, and the University of Washington have kept open dialogue throughout the pilot program and met in April 2024 for a collaborative discussion on how the program went.

Licensing requested that the licensee reach out to the University of WA Administration, University Police Department, and the City of Seattle Police Department for their input on the pilot program including if there were any concerns with another pilot due to the direct impact. All three departments submitted letters in support of permanent allowance of beer and wine in the stands for general seating. In their written responses, there was a unified sentiment that the numbers show the pilot program worked well and that not allowing patrons to leave and re-enter has continued to help significantly. The University of Washington Police Department stated that the positive management of alcohol sales and consumption contributed to very few alcohol-related incidents at Husky Football games in 2023. The Seattle Police Department also stated that they reached out to their North Precinct and collectively there was not an increase in calls for assistance. Lastly, we asked for any driving while intoxicated (DUI) incidents from the Last Call report. Enforcement Captain, Tom Dixon was able to provide them with that information which showed that there was only one incident reported for 2023.

Security and Safety Measures

The University of WA through its operator Aramark Sports and Entertainment Services, LLC partnered on implementing the following and will continue to do so through the 2024 season:

- Signage was maintained on the perimeter of the building and prior to all entrance points indicating no alcohol consumption allowed in entry lines. Signage was also maintained around the student section stating no alcohol is allowed.
- Thirty-eight Alcohol Enforcement (AE) staff were deployed outside of Husky Stadium to monitor lines at all public points of entry for open containers and visibly intoxicated fans. Higher-volume entry points had more AE staff. Containers were removed from patrons and anyone who was visibly intoxicated wasn't granted entry.
- Ten AE Guards were stationed at points of entry to the student section to assist ushers with monitoring to prevent alcohol entering the student section.
- Nine additional identifiable AE rovers were on-duty moving throughout the student section monitoring for underage possession and consumption. Any minors in possession were removed from the building.
- AE personnel were assigned to monitor compliance with ID checking, two drink limit, and overservice policies.
- New for the 2023 season, vertical IDs were no longer accepted for alcohol sale verification.

Licensing's Recommendation

Licensing is recommending the approval of University of Washington and Aramark moving out of the pilot program at Husky Stadium and making the requested levels of service approved without additional requirement. The licensee and university are retaining significant changes in their security measures that we feel drastically assisted in ensuring public safety during the previous pilot year and will continue to do so well into the future. Additionally, Enforcement will continue monitoring the facility in partnership with the licensee to ensure the safety of the student body and public is held in high import.

Pilot Program Re-evaluation

If the board agrees, there will be no requirement for annual re-evaluation of the levels of service requested. However, Enforcement premises checks will continue and the LCB retains the right to require reductions in approved levels of service should Aramark and UW fail to maintain the current levels of success concerning prevention of service to minors, overconsumption, and risk to public safety.

Re: Aramark @ University of Washington Request for Permanent Approval

Dear Ms. Reid:

On behalf of Aramark Sports and Entertainment Services, LLC ("Aramark"), this letter requests consideration to move from Pilot Program status to Permanent Approval status allowing beer and wine consumption in non-student sections of the general seating area at the University of Washington Husky Stadium ("Husky Stadium") on the University of Washington ("UW") campus. As previously conveyed, the request does not extend to the student seating section and fans will not be able to leave and re-enter the stadium during games.

During the three years of the Pilot Program, total documented alcohol incidents were minimal due to implementation of mitigation measures (discussed below) that Aramark put into place for the 2021 - 2023 seasons compared to the 2019 Husky Football season.¹

University of Washington Administration, University of Washington Police Department, and City of Seattle Police Department have provided letters unanimously voicing support for Aramark and the program they have implemented. See attachments I-III.

WSLCB Enforcement Captain Tom Dixon has confirmed there has only been one DUI "Last Drink" report out of Husky Stadium for the period running from January 1, 2019 through November 30, 2023. See attachments IV – VI.

Implemented Mitigation Measures

Aramark and UW collaborated to add the following mitigation measures during the pilot program:

<u>Increased Security Staffing and Enhanced Policy at Stadium Entrances</u>: Signage has been added around the perimeter of the building and to all entrance points indicating no alcohol consumption is allowed in entry lines. Thirty-eight Alcohol Enforcement ("AE") staff are deployed outside of Husky Stadium to monitor lines at all public points of entry for open containers and visibly intoxicated fans. Higher numbers of AE personnel are assigned to higher-volume entrance points. Alcohol enforcement will remove open containers

¹ In response to feedback from the WSLCB regarding our 2022 season, Alcohol Enforcement staff were pushed to heighten assessment of fans for intoxication during the 2023 season. This appropriately resulted in an increased number of alcohol-related refusals of entry and ejections in 2023 and supported the primary goal of providing a safe environment at Husky Stadium.

from fans close to the perimeter of the building. Fans appearing to be visibly intoxicated will be removed from lines and not be allowed to enter the stadium.²

<u>Alcohol Enforcement Personnel in Student Section</u>: AE Entrance Guards are stationed at points of entry to the student section to assist ushers with monitoring to prevent alcohol entering the student section. Additional signage is displayed throughout the student section reinforcing the message that no alcohol is allowed in the section. Nine additional identifiable AE rovers are on-duty moving throughout the student section monitoring for underage possession and consumption.³ Minors in possession will be removed from the stadium.

Subject: Sale of beer & wine in general concessions in 2024 Football Season and beyond

The University of Washington is requesting full WSLCB approval to allow beer and wine sales and consumption in the general seating areas in Husky Stadium. This request is respectfully made after completing three pilot program years (2021, 2022, 2023) and in full partnership with our concessionaire, Aramark and the University of Washington Police Department.

Prior to the 2021 pilot season, the UW Athletic Department engaged in extensive discussions with various constituent groups and officials, including license holder and partner Aramark. We researched how UW could undertake stadium wide sales while creating a safer environment for all fans. Major modifications to our game day experience followed including eliminating "in and out" entry access to the Stadium and more aggressive monitoring of alcohol consumption for fans throughout the event. Our 2021 and 2022 season data did show a decline in the amount of alcohol related fan ejections compared to previous seasons. We were encouraged by these numbers and believe our "no re-entry" policy contributed to curbing excessive pregame consumption.

In response to feedback from the WSLCB regarding our 2022 season, we pushed our Alcohol Enforcement staff to be stricter in their assessment of intoxicated fans. This did result in increased alcohol-related ejections and supported our primary goal of providing a safe environment at Husky Stadium.

UW Athletics and UWPD are continuing to collaborate on evaluating the Husky Stadium ejection policy. We value our strong partnerships with UWPD and SPD, and representatives from both organizations have written letters of support for continued sales at Husky Stadium.



SUBJECT: Aramark @ University of Washington

During the 2023 University of Washington football season LCB Enforcement Officers visited three home games (9/23/23, 11/13/23 and 11/25/23). These visits totaled approximately 6.5 hours spent in the stadium.

Our officers observed a few patrons showing signs of apparent intoxication at each game. However, in all cases these patrons were not in possession of alcohol and were being appropriately addressed by stadium staff.

In addition, at the 9/23/23 game our officers caught an underage patron attempting to purchase alcohol using a fraudulent ID. This patron was reported to stadium staff and they escorted him out of the stadium per their policy.

Our officers observed that alcohol service was ended at the appointed time consistent with the current operating plan.

Throughout the season, Melinda Altamirano and her staff were very helpful and cooperative. They were responsive to all questions we had and all suggestions we offered.

During the time this pilot program has been in place, LCB Enforcement Officers have not observed any appreciable degradation in public safety related issues in or around the stadium.
