Subject: Approval to file a preproposal statement of inquiry (CR101) relating to allowing sale of cannabis waste.

The Washington State Liquor and Cannabis Board (Board) is amending WAC 314-55-097 and other rules as may be required to implement Substitute Senate Bill 5376 (Chapter 243, Laws of 2024) relating to allowing sale of non-hazardous cannabis waste, including sales of cannabis waste to persons who are not cannabis licensees.

Process

The Policy and Rules Coordinator requests approval to file the preproposal statement of inquiry (CR101) for the rule making described above. A CR 101 Memorandum was presented at the Board meeting on May 22, 2024 and is attached to this order.

If approved for filing, the <u>tentative timeline</u> for the rule making process is outlined below:

May 22, 2024	 Board is asked to approve filing notice of expedited rulemaking (CR 105). CR 105 is filed with the Office of the Code Reviser. Webpage is updated and notice circulated by GovDelivery distribution list. 45 day expedited rulemaking public comment period begins.
June 5, 2024	Notice published in the Washington State Register.
July 31, 2024	Board is asked to approve CR 102

September 11, 2024	Public Hearing on proposed rules
September 25, 2024	Board is asked to approve permanent adopt rules if no substantive changes are made (CR 103). CR 103 and adopted rules are filed with the Office of the Code Reviser. LCB webpage updated and notice circulated to all WSLCB GovDelivery subscribers.
October 26, 2024	Rules are effective 31 days after filing (unless otherwise specified).

CR 101 Memorandum

Allowing sale of cannabis waste.

Background

The Liquor and Cannabis Board is beginning rulemaking to implement Substitute Senate Bill (SSB) 5376 (Chapter 243, Laws of 2024) related to allowing the sale of cannabis waste. The legislation becomes effective on June 6, 2024. The legislation permits a licensed cannabis producer and a licensed cannabis processor to sell cannabis waste to a person(s) who is not cannabis licensee under certain conditions, as follows:

- 1. The cannabis waste is not designated as hazardous waste;
- 2. The licensee notifies the board and the Washington state department of agriculture before the sale; and
- 3. The licensee makes all sales available to the public on an equal and nondiscriminatory basis.

The legislation also defines "cannabis waste" as solid waste generated during cannabis production or processing that has a THC concentration of 0.3% or less. Cannabis waste does not include "hemp" or "industrial hemp," which have existing definitions in RCW 15.140.020.

The current regulations (WAC 314-55-097) requires cannabis waste that is not classified as dangerous be made unusable before disposal. To render cannabis waste unusable, it must be ground up and mixed with other materials to at least 50% non-cannabis content. Compostable waste can be mixed with food, yard waste, or vegetable oils, while non-compostable waste can be combined with paper, cardboard, plastic, soil, or other approved materials.

Reasons Why Rulemaking Is Needed

Rulemaking is needed to amend WAC 314-55-097 and amend, repeal, or create other sections of Title 314 WAC, as necessary, to implement SSB 5376. **Process**

The rulemaking process begins by announcing the Board's intent to consider changes to existing rules, adding new rule sections, or both, by filing a

preproposal statement of inquiry (CR 101) form with the Office of the Code Reviser. This allows staff, stakeholders, industry partners, and all members of the authorizing environment to begin discussing proposed rule changes.

At this stage of the rulemaking process, no proposed language is offered. Any interested party may comment on this possible rulemaking during the designated comment period. Notice will be sent to all who have indicated that they want to receive notice of rule activity related to this preproposal statement of inquiry. The notice will identify the public comment period and where comments can be sent.
