

### Marijuana-Infused Product, Label, and Package Application for New Rules

A marijuana processor licensee must obtain approval from the Liquor and Cannabis Board (LCB) for all marijuana-infused products, labeling, and packaging prior to offering these items for sale to a marijuana retailer.

Please complete this form thoroughly and submit the completed application directly to <u>labelapproval@lcb.wa.gov</u>. Label submission will be reviewed for compliance within 14 business days. Complete label submissions will be presented to the label approval team for a decision to be made within seven business days of label review. An approval or denial letter will be emailed to the licensee within two business days of decision. For more information please visit <u>lcb.wa.gov</u>. ## Section 2: Package, Label and Product Requirements

# Packaging and labeling for marijuana infused edibles must meet and comply with the standards and requirements in:

- Washington Administrate Codes 314-55-077, 314-55-105, 314-55-106 and 314-55-155
- NIST Handbook 130 and Uniform Packaging and Labeling Regulation adopted in chapter 16-662 WAC
- Child resistant packaging in accordance with Title 16 C.F.R. 1700 of the Poison Prevention Packaging Act

**Symbols:** The "not for kids" warning symbol <u>and</u> the marijuana "universal symbol" are required on the principal display panel or front of the product package

## Optional information to be included on labels are:

- Retailer business/trade name and UBI number
- Harvest date
- Date manufactured
- Best by date

### New definitions:

"Cartoon" means any drawing or other depiction of an object, person, animal, creature, or any similar caricature that satisfies any of the following criteria:

- The use of comically exaggerated features
- The attribution of human characteristics to animals, plants or other objects, or the similar use of anthropomorphic technique
- The attribution of unnatural or extra-human abilities, such as imperviousness to pain or injury, X-ray vision, tunneling at very high speeds, or transformation

"Especially appealing to children" means a product, label, or advertisement that includes, but is not limited to, the following:

- The use of cartoons
- Bubble-type or other cartoon-like or action font
- The use of bright colors similar to those used on commercially available products intended for or that target youth or children
- A design, brand, or name that resembles a noncannabis consumer product of the type that is typically marketed to minors
- Symbols or celebrities that are commonly used to market products to minors
- Images of minors
- Similarities to products or words that refer to products that are commonly associated with minors or marketed to minors
