# **NOTICE OF RULE MAKING – Pre-proposal - #17-29**

The Washington State Liquor and Cannabis Board has entered into the initial stage of rulemaking (CR 101) to consider rule changes regarding cannabis production canopy as it relates to supply and demand for cannabis within Washington State. Rule change proposals will address how the WSLCB may adjust canopy amounts to keep pace with demand for cannabis products (increases or decreases) should adjustments become necessary. Current rule, WAC 314-55-075 subsections (7) and (8), includes some provisions for reductions in individual canopy or for exceeding all canopy, but does not address other instances where canopy adjustments may be advisable or required, including any increases. Rule proposals will provide conditions and parameters for additional canopy adjustments. The CR 101 is the initial notification of potential rulemaking and no rule language is offered at this stage of the process.

The Liquor and Cannabis Board encourages you to give input on the subject of these potential changes. Following the comment period, the agency will send out and publish the proposed rules, establish a comment period on the proposed rules, and hold a public hearing before the rules are adopted.

# **Cannabis Production and Canopy Rules**

### **Description of the Issue**

This Issue Paper requests approval from the Board to file the first stage of rulemaking (CR 101) for changes to rules relating to Cannabis Production and Canopy in Chapter 314-55 WAC.

### Why is rule making necessary?

The WSLCB is considering rule changes regarding cannabis production canopy as it relates to supply and demand for cannabis within Washington State. Rule change proposals will address how the WSLCB may adjust canopy amounts to keep pace with demand for cannabis products (increases or decreases) should adjustments become necessary. Current rule, WAC 314-55-075 subsections (7) and (8), includes some provisions for reductions in individual canopy or for exceeding all canopy, but does not address other instances where canopy adjustments may be advisable or required, including any increases. Rule proposals will provide conditions and parameters for additional canopy adjustments.

#### **Process**

The rule making process begins by announcing LCB's intent to add and make changes to existing rules by filing a CR 101 form. This allows staff and stakeholders to begin discussing necessary rule changes. At the CR 101 stage of the rulemaking process, no proposed language is offered. The public may comment on the subject of this rulemaking during the designated comment period. Notice will be sent to all who have indicated that they want to receive notice of rule changes. The notice will identify the public comment period and where comments can be sent. Based on public input received, staff will draft proposed changes for presentation to the Board at the next phase of the rule making process.
