Process Overview

- The CR 101 was filed November 8, 2023.
- During the informal public comment period we received 30 written comments.
- LCB conducted an initial survey of applicants who participated in the application process under HB 2870 (73 respondents.)
- LCB contracted with Whitney Economics to provide information on thresholds for license types by county.
- Stakeholder engagement sessions held on May 15 and May 22, 2024.
- Draft rules were publicly shared with an accompanying survey.
- Survey responses were collected from July 11 to July 18, 2024 (242 respondents.)
- A public hearing on the CR-102 draft rules was held on Sept. 11, 2024.

Substantive Changes

- Registration window(s).
- Scoring Rubric.
- Statewide mobility option for applicants who applied under HB 2870 qualifications.
- Title Certificate Holders.

Registration Window

- There will be two separate registration windows.
- Retailer registration will be the first window to open.
- Producer processors will be second.
- This allows individuals not receiving a high enough application score in the retail process to apply again as a producer and processor.

Scoring Rubric

The goal of the scoring rubric was to provide registrants point accumulation related to the level of impact an individual may have experienced based on the war on drugs, and link impacts to qualifications established in statute.


Scoring was developed and drafted based on a general assessment of direct impacts to an applicant, and stakeholder feedback from verbal, written, and survey submissions.


To ensure familiarity of scores compared to previous rules and proposed changes, the scores in each category match the overall percentage weight on a 300-point scale.




Rubric Comparison – Disproportionately Impacted Area (DIA)










Rubric Comparison – Arrest and Conviction










Rubric Comparison – Household Income









Rubric Comparison – Socially and Economically Disadvantaged

HB 2870 Applicant Mobility

- Clarifies statewide mobility options.
- Delayed the effective date of when statewide mobility starts.
- Previously effective 90 days after the registration closes.
- Now effective January 01, 2026.
- Added limitations to mobility based on the licensees' original application score under of HB 2870.
- Rules only allow for relocation into a different county if the HB 2870 licensee has not opened and if their application score exceeds the lowest successful application score for the desired county.

Title Certificate Holder

- Title certificate holder: Maintained previous agency policy, where a location must be in the original county of application.
- Title certificate holders will also be able to apply for a new social equity license under SB 5080.
- The rules establish title certificate holders will be able to register for both a reinstatement of the license and apply for a license which can be located statewide.
- The application window will be the same for reinstatement of title certificates and new social equity retail applications.
- In general, only one registration is allowed during each application window.
- Registering for reinstatement will not prevent registering for a new license application.
